**RESOLUTION – ORDER FIXING TIME OF VIEW AND FIRST HEARING TO VACATE THE SEAMAN DITCH  
LOCATED IN BAY TOWNSHIP  
Ohio Revised Code Section 6131.07**

The Board of County Commissioners of the County of Ottawa, Ohio, met in regular session at the office of the Board of County Commissioners, Ottawa County Courthouse, Port Clinton, Ohio, on the 1<sup>st</sup> day of April 2021, at the regular place of meeting with the following members present:

Commissioner Coppeler moved the adoption of the following Resolution:

**WHEREAS**, on the 24<sup>th</sup> day of March 2021, the Assistant Clerk of this board gave notice to the Board of County Commissioners and the County Engineer of Ottawa County, Ohio, on the filing with her a petition received March 23, 2021 signed by Todd Winke, petitioner(s), to initiate the process to vacate Seaman Ditch located in Bay Township; and

**WHEREAS** it appears to said Board that the proper bond has been filed with the Assistant Clerk, approved, conditioned for the payment of costs of notices, plus any other incidental expenses, except the costs incurred by the Engineer in making his preliminary reports, if the prayer of the petition is not granted, or if said petition is for any cause dismissed, unless the Board decides to pay the Engineer's costs from the bond in accordance with Section 6131.09 of the Revised Code; therefore, be it

**RESOLVED**, by said Board of County Commissioners, that the 11<sup>th</sup> day of May 2021, at 1:30 p.m. at 5385 West Oak Harbor Southeast Road, Oak Harbor, Ohio, be and the same is hereby fixed as the time and place for the view. The viewing is an opportunity for the Commissioners and County Engineer to gather field information about the proposed improvement; and be it further


