*The undersigned hereby petition your honorable body to initiate the process to vacate Seaman Ditch located in Bay Township.*

*On the course hereinafter set forth.*

*The vacation of the existing improvement is necessary and will be conducive to the public welfare.*

*The following is the course and termini of said existing improvement, to-wit:*

*Commencing approximately 2,834 feet West of the intersection of Darr-Hopfinger Road, C.R. 12, and Mulcahy Road, C.R. 27, thence westerly along the North side of Darr-Hopfinger Road then northerly for a total distance of approximately 3,265 feet to its terminus in the Little Portage Wildlife Area.*

*All costs of engineering, construction, and future maintenance will be assessed to the benefiting parcels of land, except under Section 6131.31 of the Revised Code.*

*The following is the nature of the work petitioned for: Petitioner requests to vacate Seaman Ditch located in Bay Township.*
